It was the first standard on High-level Annex SL structure published by ISO. BS7799 itself was a long-standing standard, first published in the nineties as a code of practice. As this matured, a second part emerged to cover management systems. It is this against which certification is granted. Today in excess of a thousand certificates are in place, across the world. The objective of the standard itself is to “provide a model for establishing, implementing. Operating, monitoring, reviewing, maintaining, and improving an Information Security Management System”. Regarding its adoption, this should be a strategic decision.

The design and implementation of an organization's ISMS are influenced by their needs and objectives, security requirements, the process employed and the size and structure of the organization. The standard defines its ' process approach as the application of a system of processes within an organization, together with the identification and interactions of these processes, and their management”. It employs the PDCA, Plan-Do-Check-Act model for structuring he processes. Information is critical to the operation and perhaps even the survival of your organization. Being certified to ISO/IEC 27001 will help you to manage protect your valuable information assets. ISO/IEC 27001 is the only auditable international standard which defines the requirements for an Information Security Management System (ISMS). The standard is designed to ensure the selection of adequate and proportionate security controls. This helps you to protect your information assets and give confidence to any interested parties, especially your customers. The standard adopts a process approach for establishing, implementing, and evaluation, operating, monitoring, reviewing, maintaining, and improving your ISMS.

ISO 22301 (Business Continuity Management System)

BCM is the need of time; contingency planning and disaster recovery were largely information technology-led responses to natural disasters and terrorism that affected businesses during the 1980s and early 1990s

There was a growing recognition, however, this become a business-led process and encompass preparing for many forms of disruption. In light of this, the discipline became known as business continuity management (BCM).

As governments and regulators began to recognize the role of business continuity in mitigating the effects of disruptive incidents on society, they increasingly sought to gain assurance that key players had appropriate business continuity arrangements in place. Similarly, businesses recognized their dependence on each other and sought assurance that key suppliers and partners would continue to provide key products and services, even when incidents occurred.

ISO 22301 is a management systems standard for BCM which can be used by organizations of all sizes and types. These organizations will be able to obtain accredited certification against this standard and so demonstrate to legislators, regulators, customers, prospective customers and other interested parties that they are adhering to good practice in BCM. ISO 22301 also enables the business continuity manager to show top management that a recognized standard has been achieved.

ISO 21001 (Educational Organizations Management systems)

ISO 21001 specifies requirements for a management system for educational organizations (EOMS) when such an organization:

A) needs to demonstrate its ability to support the acquisition and development of competence through teaching, learning or research;

B) Aims to enhance satisfaction of learners, other beneficiaries and staff through the effective application of its EOMS, including processes for improvement of the system and assurance of conformity to the requirements of learners and other beneficiaries.

All requirements of ISO 21001 are generic and intended to be applicable to any organization that Uses a curriculum to support the development of competence through teaching, learning or Research, regardless of the type, size or method of delivery. ISO 21001 can be applied to educational Organizations within larger organizations whose core business is not education, such as professional Training departments.

ISO 21001 does not apply to organizations that only produce or manufacture educational products.

ISO 22000 (Food Safety Management System)

ISO 22000 is an international standard that defines a food safety management system's requirements covering all organizations in the food chain from (farm to fork). The standard combines generally recognized key elements to ensure food safety.

The food chain, including Interactive communication Systems management Control of food safety hazards through pre-requisite programs and HACCP, plans continual improvement and updating of the food safety management system.

ISO 22000 is a truly international standard suitable for any business in the entire food chain, including inter-related organizations such as producers of equipment, packaging material, cleaning agents, additives and ingredients. ISO 22000 is also for companies seeking to integrate their quality management system, for example, ISO 9001 and their food safety management system. DAS Pakistan (Pvt.) ISO/IEC 20000-1 (Information Technology Management Systems)

This Standard specifies requirements for an organization to establish, implement, maintain and continually improve a service management system (SMS). The requirements specified in this Standard include the planning, design, transition, delivery and improvement of services to meet the service requirements and deliver value. This Standard can be used by:

- A customer seeking services and requiring assurance regarding the quality of those services;
- A customer requiring a consistent approach to the service lifecycle by all its service providers, including those in a supply chain;
- An organization to demonstrate its capability for the planning, design, transition, delivery and improvement of services;
- An organization to monitor, measure and review its SMS and the services;
- An organization to improve the planning, design, transition, delivery and improvement of services through effective implementation and operation of an SMS;
- An organization or other party performing conformity assessments against the requirements specified in this document;
- A provider of training or advice in service management.



The term "service" as used in this Standard refers to the service or services in the scope of the SMS. The term "organization" as used in this standard refers to the organization in the scope of the SMS that manages and delivers services to customers. The organization in the scope of the SMS can be part of a larger organization, for example, a department of a large corporation. An organization or part of an organization that manages and delivers a service or services to internal or external customers can also be known as a service provider. Any use of the terms "service" or "organization" with a different intent is distinguished clearly in this Standard.

HACCP (Hazard Analysis & Critical Control Points)

HACCP-Hazard Analysis and Critical Control Point (HACCP) is a systematic approach to identifying and controlling hazards (i.e., microbiological, chemical, or physical) that could pose a threat to the preparation of safe food. HACCP involves identifying what can go wrong planning to prevent it, making sure you are doing it. In simple terms, it involves controlling ingredients and supplies coming into a catering business and what is done with them thereafter. Prerequisites before implementing HACCP, basic food hygiene conditions, and practices called prerequisites must be in place in a food catering business. HACCP will be used to control steps in the business, which are critical in ensuring the preparation of safe food. HACCP uses an approach to food safety, which concentrates caterer attention on the causes of food safety hazards. This allows a caterer to identify and control food safety hazards. The advantage of an effective HACCP team is that members tend to have in-depth knowledge of all aspects of the operation, which reduces the risk of details being overlooked. In addition, a team setup will instill ownership of HACCP by the catering business.

Examine the business and make sure all members of the HACCP team are familiar with its daily food preparation procedures.

Scope of CE Marking Services

What is CE Marking?

The CE symbol indicates that the product conforms to the essential safety requirements laid down in one or more EU directives applicable to the product itself. It must be affixed to the product before it is placed on the market, except in cases where the specific directives provide otherwise. It should be affixed on the product and /or packaging and/or instructions for use.

The CE Marking of Product Mandatory

The CE marking is mandatory for all products that fall into one of the Community Directives relating to the CE marking in the European Union member countries.

Applicable EC Directives will change depending on the type of product. For each directive is available, the list of harmonized standards to which the product should be subject, so it is impossible to affix the CE mark without first carrying out all the tests set out by the legislation.

Who should affix the CE Mark?

The CE marking must always be affixed by the manufacturer, even if he lives outside the European Union. Documentation required by Manufacturer Importer for CE Mark.

The manufacturer (or the importer, in the case of goods produced outside the EU) must:

Draw up a "CE declaration of conformity" which indicates the directive /applied and standards use. Prepare and keep a "technical construction file" descriptive of the technical characteristics of the product and tests carried out, proving the safety of the product itself.

Warning! Declare compliance with harmonized standards means having successfully followed all the tests required by them. This documentation must be available on the request of the competent authorities to monitor the market.
